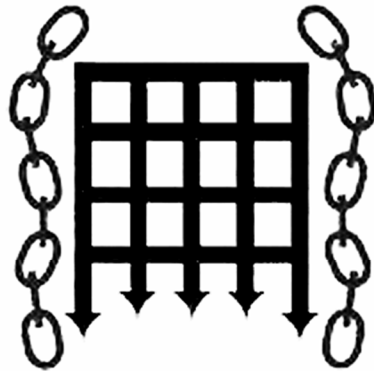

Information:

The client has noticed unusual activity with his partner Leanne Hill who will now be referred to in this report as S1 (Subject 1) and suspects infidelity. She has become very secretive around her mobile phone but the client saw a notification flash up on her phone from a Roger Kyle saying "Can't wait to see you Tuesday xxx". The client has heard S1 mention a Roger Kyle before and knows him to be a work colleague of hers that works in another department in Nottingham. Roger Kyle will now be referred to in this report as S2 (Subject 2).

Aim of surveillance:

To get photographic and video evidence of the Subject and all interactions with any males. When they depart, to then follow Subject 2 to ascertain an address for him.

Description of subject1: Leanne Hill is a 29-year-old female with long blonde hair slim build. Lives at 23 High Street Coventry CV1 2AA drives a red Ford fiesta.



Description of Subject 2: Roger Kyle White male 28 years short dark hair. Vehicle unknown, address unknown.



Time: Remarks & Relevant Information:

Tuesday 11th November 2021

07:57 Observations begin at the home address of S1.

08:03 S1 exits alone and walks a short distance to her vehicle. She is followed out of the city.





09:15 S1 arrives at a McDonald's in Nottingham where she takes a seat and is soon joined by a male fitting the description of S2 and they both embrace and kiss on the lips.



S1 & S2 kiss.

They sit on opposite sides of the table and hold hands whilst engaging in conversation.



09:33 they both stand up and put their coats on, S1 is helped by S2 and they exit the restaurant and enter the car park holding hands.





They stop behind S1's vehicle a ford Fiesta VRM FL14 SGY and engage in a kiss before driving away in separate vehicles, S1 in the Fiesta and S2 in a white Nissan Note DC65 JWM.



They drive away in tandem and are followed to Wollaton Country Park Nottingham. They both park next to each other and exit their respective vehicles and again embrace and kiss after changing into outdoor clothing and walk through the country park, holding hands, snatching kisses and playfully running and piggy backing.





They then purchase hot drinks from a cafeteria within the grounds and then take a seat on a bench and again embrace, tell jokes and kiss.





They both walked back through the park. Due to keeping operatives' exposure levels down, a drone is deployed and utilised to track the couple through the park towards their vehicles and operatives await their return.



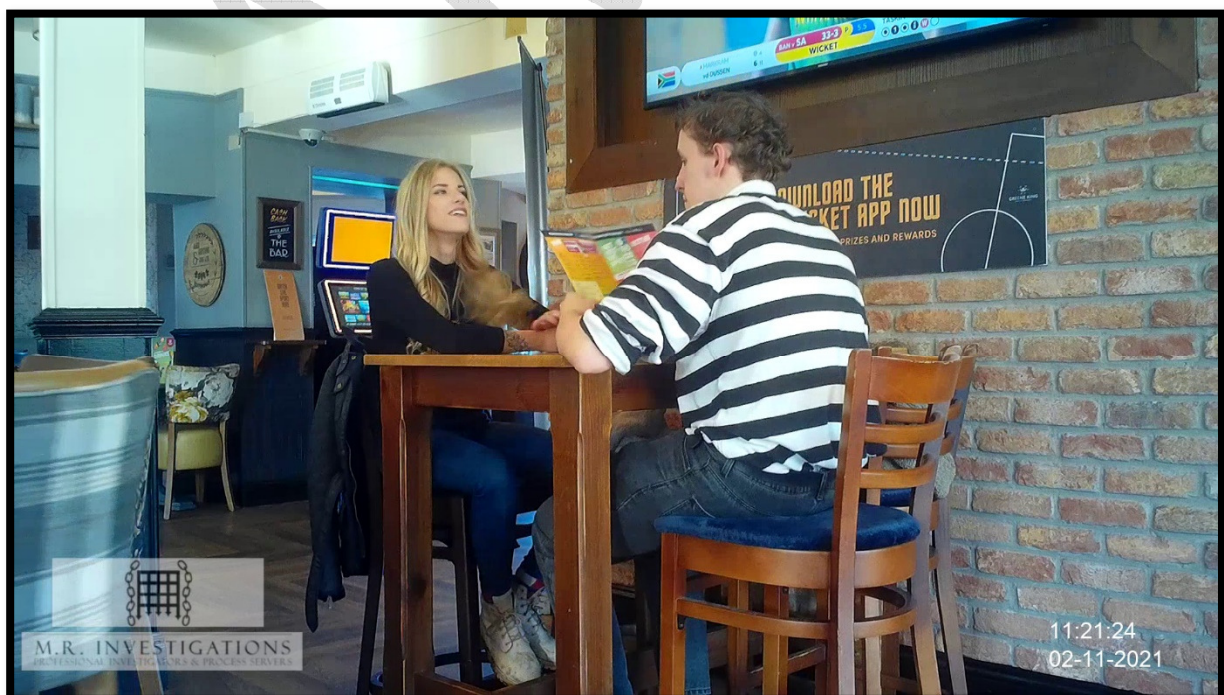
Once at their cars they again embrace and kiss and then drive away in their respective vehicles.



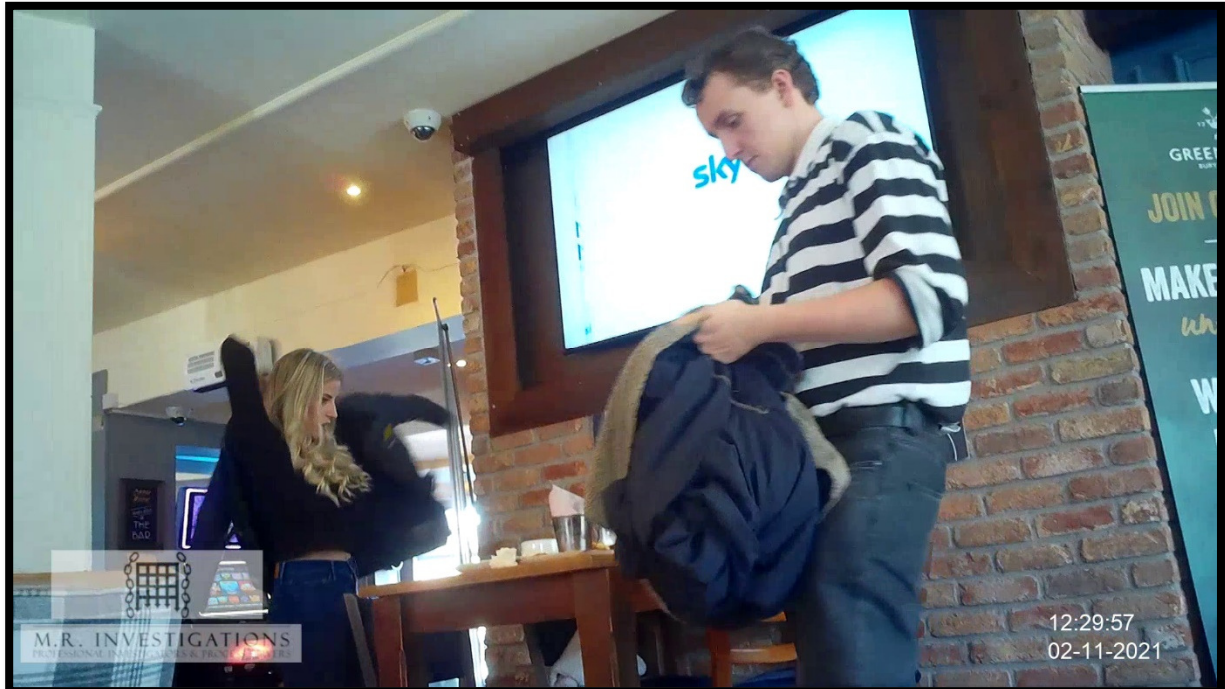
11:14 They arrive at the nearby Nags Head Public house car park, just across the road from the entrance to the country park where they exit their vehicles and walk inside the public house together.



They take a seat opposite each other and order food and drinks from the menu. They continuously laugh, joke and hold hands.



12:29 having consumed their food both S1 & S2 put on their coats and exit the public house and walk to their respective vehicles. S1 gets into her vehicle and S2 talks to her before giving a lingering good bye kiss on the lips. They both depart in different directions and operatives concentrate on S2 to ascertain his home address.







S2 was followed to 123 Carlton Street, Nottingham, NG1 2NG where he entered via a wooden front gate and into the property via a front door. Open-source desk top enquiries confirmed this as being the home address of S2 as well as a Kerry Kyle. Social media enquiries show that Kerry is the wife of S2.

Conclusion:

Operatives are under no illusions that this is anything other than an extra marital affair by both Subjects. They were seen to kiss and embrace numerous times, as well as hold hands and their actions could not in any way be misconstrued as platonic.
